

Carbon Border Adjustment Mechanism – downstream extension, additional anti-circumvention measures and rules for the electricity sector

Introduction

The EU's Carbon Border Adjustment Mechanism (CBAM) is the EU's tool to put a fair price on the carbon emitted during the production of carbon intensive goods that enter the EU, and to encourage cleaner industrial production in non-EU countries. It aims to prevent carbon leakage, which occurs if, for reasons of costs related to climate policies, businesses in certain industry sectors or subsectors transfer production to other countries or imports from those countries replace equivalent products that are less intensive in terms of greenhouse gas emissions.

CBAM targets the embedded carbon emissions of products imported into the EU in specific sectors that are within the scope of the EU Emissions Trading System (ETS) and the most at risk of carbon leakage. These are: cement, iron and steel, aluminium, fertilisers, hydrogen and electricity. The instrument ensures that imports of these goods face a carbon cost, mirroring the carbon price paid by domestic producers of the same goods under the EU ETS. This helps safeguard the EU's climate objectives and contributes to lower global greenhouse gas emissions overall.

To help prevent carbon leakage, Art. 30 of the CBAM Regulation ([Regulation \(EU\) 2023/956](#)) sets out a possible extension of CBAM's scope to products downstream from goods currently in scope. The recently adopted Commission's [Steel and Metals Action Plan](#) (March 2025) further highlights these aspects.

Firstly, carbon leakage in CBAM-covered goods could shift further **downstream** in the value chain, i.e., to goods that use CBAM-covered goods as inputs. This could arise if companies downstream to CBAM goods that currently produce in the EU move their manufacturing and processing operations to non-EU countries with laxer climate policies or if end consumers purchase downstream products that are less expensive because of less stringent climate policies in the producing country. In addition, companies may try to avoid CBAM by making enough minor transformations to the CBAM basic goods outside the EU to not be subject to CBAM anymore, and then importing the slightly altered downstream products without having to pay the CBAM financial adjustment at the EU border.

Secondly, there is a risk of **circumvention** of CBAM arising from practices aiming to reduce the amount of financial liabilities associated with the embedded emissions. In addition to the practices highlighted above, there is also a risk of resource shuffling whereby goods produced in low-carbon production facilities in non-

EU countries are redirected to European customers while high-carbon sales continue or even increase in non-EU markets, thereby undermining CBAM's environmental effectiveness and benefiting producers who can reallocate clean and less clean production between the EU market and non-EU markets.

In view of these considerations, in the Steel and Metals Action Plan the Commission committed to presenting a legislative proposal by the end of 2025, extending the scope of CBAM to certain steel and aluminium-intensive downstream products and including additional anti-circumvention measures. The selection of downstream products to be added to the CBAM scope would rely on analogous criteria to those that guided the initial scope of CBAM, namely the risk of carbon leakage which depends on the tradability and the carbon cost, the relevance of embedded emissions and the technical feasibility.

Furthermore, in light of the lessons learned in the transitional period, the rules for **electricity** have been identified as very difficult to implement due to the specific characteristics of electricity as a good. Currently, the default values applied are based on the emission factor of fossil electricity production. Alternatively, actual emissions can be reported. Yet, the conditions are very difficult to meet. This design might impede incentives for decarbonisation in non-EU countries and thereby reduce the effectiveness of CBAM.

This consultation aims at gathering the opinions of all stakeholders on these issues with a view to an amendment of the CBAM Regulation.

Definitions

- **CBAM basic goods** are goods covered by CBAM in six sectors: aluminium, cement, electricity, fertilisers, hydrogen, and iron & steel. They are listed in Annex I of the CBAM Regulation, Regulation (EU) 2023/956.
- **Downstream goods** are products further down the value chain from CBAM basic goods. In this survey, the CBAM good electricity is not considered an input for determining downstream goods.
- **Carbon leakage** occurs if, for reasons of costs related to climate policies, businesses in certain industry sectors or subsectors transfer production to other countries or imports from those countries replace equivalent products that are less intensive in terms of greenhouse gas emissions.
- **Downstream carbon leakage** could arise if companies downstream to CBAM goods that currently produce in the EU move their manufacturing and processing operations to non-EU countries with laxer climate policies or if end consumers purchase downstream products that are less expensive because of less stringent climate policies in the producing country.
- **Circumvention** is understood to arise from any practices for which there is insufficient due cause or economic justification, other than to effectively avoid, wholly or partially, the financial liabilities arising from CBAM, undermining the environmental integrity of the mechanism.
- **Resource shuffling** is the risk that goods produced in low-carbon production facilities in non-EU countries are redirected to EU customers while carbon-intensive production continues for other markets.
- **Importer** means either the person lodging a customs declaration for release for free circulation of goods in its own name and on its own behalf or, where the customs declaration is lodged by an indirect customs representative in accordance with Article 18 of [Regulation \(EU\) No 952/2013](#), the person on whose behalf such a declaration is lodged (Article 2(15) CBAM Regulation).
- **Customs representative** means any person appointed by another person to carry out the acts and formalities required under the customs legislation in their dealings with customs authorities (Article 5 (6) [Union Customs Code](#)).

- **Transmission system operator (TSO)** means a natural or legal person who is responsible for operating, ensuring the maintenance of and, if necessary, developing the transmission system in a given area and, where applicable, its interconnections with other systems, and for ensuring the long-term ability of the system to meet reasonable demands for the transmission of electricity (Art. 2(35) [Directive on internal market for electricity](#)).
- **Capacity nomination** means the notification of the use of long-term cross-zonal capacity by a physical transmission rights (PTRs) holder and its counterparty to the respective Transmission System Operators (TSOs) (Article 2(7) [Commission Regulation \(EU\) 2016/1719](#)).
- **Power purchase agreement** means a contract under which a person agrees to purchase electricity directly from an electricity producer (point 1(f) Annex IV CBAM Regulation).
- **Physical network congestion** means any network situation where forecasted or realised power flows violate the thermal limits of the elements of the grid and voltage stability or the angle stability limits of the power system (Article 2, point (18) [Commission Regulation \(EU\) 2015/1222](#)).

8201 - Hand tools, the following: spades, shovels, mattocks, picks, hoes, forks and rakes; axes, billhooks and similar hewing tools; secateurs and pruners of any kind; scythes, sickles, hay knives, hedge shears, timber wedges and other tools of a kind used in agriculture, horticulture or forestry

8202 - Handsaws; blades for saws of all kinds (including slitting, slotting or toothless saw blades)

8203 - Files, rasps, pliers (including cutting pliers), pincers, tweezers, metal-cutting shears, pipe-cutters, bolt croppers, perforating punches and similar hand tools

8204 - Hand-operated spanners and wrenches (including torque meter wrenches but not including tap wrenches); interchangeable spanner sockets, with or without handles

8205 - Hand tools (including glaziers' diamonds), not elsewhere specified or included; blowlamps; vices, clamps and the like, other than accessories for and parts of machine-tools or water-jet cutting machines; anvils; portable forges; hand- or pedal-operated grinding wheels with frameworks

8207 - Interchangeable tools for hand tools, whether or not power-operated, or for machine tools (for example, for pressing, stamping, punching, tapping, threading, drilling, boring, broaching, milling, turning or screw driving), including dies for drawing or extruding metal, and rock-drilling or earth-boring tools

8208 - Knives and cutting blades, for machines or for mechanical appliances

8213 - Scissors, tailors' shears and similar shears, and blades therefor

8215 - Spoons, forks, ladles, skimmers, cake-servers, fish-knives, butter-knives, sugar tongs and similar kitchen or tableware

8301 - Padlocks and locks (key, combination or electrically operated), of base metal; clasps and frames with clasps, incorporating locks, of base metal; keys for any of the foregoing articles, of base metal

8302 - Base-metal mountings, fittings and similar articles suitable for furniture, doors, staircases, windows, blinds, coachwork, saddlery, trunks, chests, caskets or the like; base-metal hat-racks, hat-pegs, brackets and similar fixtures; castors with mountings of base metal; automatic door closers of base metal

8303 - Armoured or reinforced safes, strongboxes and doors and safe deposit lockers for strong-rooms, cash or deed boxes and the like, of base metal

8304 - Filing cabinets, card-index cabinets, paper trays, paper rests, pen trays, office-stamp stands and similar office or desk equipment, of base metal, other than office furniture of heading 9403

8305 - Fittings for loose-leaf binders or files, letter clips, letter corners, paper clips, indexing tags and similar office articles, of base metal; staples in strips (for example, for offices, upholstery, packaging), of base metal

8306 - Bells, gongs and the like, non-electric, of base metal; statuettes and other ornaments, of base metal; photograph, picture or similar frames, of base metal; mirrors of base metal

8307 - Flexible tubing of base metal, with or without fittings

8308 - Clasps, frames with clasps, buckles, buckle-clasps, hooks, eyes, eyelets and the like, of base metal, of a kind used for clothing or clothing accessories, footwear, jewellery, wrist watches, books, awnings, leather goods, travel goods or saddlery or for other made up articles; tubular or bifurcated rivets, of base metal; beads and spangles, of base metal

8309 - Stoppers, caps and lids (including crown corks, screw caps and pouring stoppers), capsules for bottles, threaded bungs, bung covers, seals and other packing accessories, of base metal

8310 - Sign-plates, nameplates, address-plates and similar plates, numbers, letters and other symbols, of base metal, excluding those of heading 9405

8311 - Wire, rods, tubes, plates, electrodes and similar products, of base metal or of metal carbides, coated or cored with flux material, of a kind used for soldering, brazing, welding or deposition of metal or of metal carbides; wire and rods, of agglomerated base metal powder, used for metal spraying

8401 - Nuclear reactors; fuel elements (cartridges), non-irradiated, for nuclear reactors; machinery and apparatus for isotopic separation

8402 - Steam or other vapour generating boilers (other than central heating hot water boilers capable also of producing low pressure steam); superheated water boilers

8403 - Central heating boilers other than those of heading 8402

8404 - Auxiliary plant for use with boilers of heading 8402 or 8403 (for example, economisers, superheaters, soot removers, gas recoverers); condensers for steam or other vapour power units

8405 - Producer gas or water gas generators, with or without their purifiers; acetylene gas generators and similar water process gas generators, with or without their purifiers

8406 - Steam turbines and other vapour turbines

8407 - Spark-ignition reciprocating or rotary internal combustion piston engines

8408 - Compression-ignition internal combustion piston engines (diesel or semi-diesel engines)

8413 - Pumps for liquids, whether or not fitted with a measuring device; liquid elevators

8414 - Air or vacuum pumps, air or other gas compressors and fans; ventilating or recycling hoods incorporating a fan, whether or not fitted with filters; gas-tight biological safety cabinets, whether or not fitted with filters

8415 - Air-conditioning machines, comprising a motor-driven fan and elements for changing the temperature and humidity, including those machines in which the humidity cannot be separately regulated

8416 - Furnace burners for liquid fuel, for pulverised solid fuel or for gas; mechanical stokers, including their mechanical grates, mechanical ash dischargers and similar appliances

8417 - Industrial or laboratory furnaces and ovens, including incinerators, non-electric

8418 - Refrigerators, freezers and other refrigerating or freezing equipment, electric or other; heat pumps other than air-conditioning machines of heading 8415

8419 - Machinery, plant or laboratory equipment, whether or not electrically heated (excluding furnaces, ovens and other equipment of heading 8414), for the treatment of materials by a process involving a change of temperature such as heating, cooking, roasting, distilling, rectifying, sterilising, pasteurising, steaming, drying, evaporating, vaporising, condensing or cooling, other than machinery or plant of a kind used for domestic purposes; instantaneous or storage water heaters, non-electric

8420 - Calendering or other rolling machines, other than for metals or glass, and cylinders therefor

8421 - Centrifuges, including centrifugal dryers; filtering or purifying machinery and apparatus, for liquids or gases

8422 - Dishwashing machines; machinery for cleaning or drying bottles or other containers; machinery for filling, closing, sealing or labelling bottles, cans, boxes, bags or other containers; machinery for capsuling bottles, jars, tubes and similar containers; other packing or wrapping machinery (including heat-shrink wrapping machinery); machinery for aerating beverages

8423 - Weighing machinery (excluding balances of a sensitivity of 5 cg or better), including weight-operated counting or checking machines; weighing machine weights of all kinds

8424 - Mechanical appliances (whether or not hand-operated) for projecting, dispersing or spraying liquids or powders; fire extinguishers, whether or not charged; spray guns and similar appliances; steam or sandblasting machines and similar jet projecting machines

8425 - Pulley tackle and hoists other than skip hoists; winches and capstans; jacks

8426 - Ships' derricks; cranes, including cable cranes; mobile lifting frames, straddle carriers and works trucks fitted with a crane

8427 - Fork-lift trucks; other works trucks fitted with lifting or handling equipment

8428 - Other lifting, handling, loading or unloading machinery (for example, lifts, escalators, conveyors, teleferics)

8429 - Self-propelled bulldozers, angledozers, graders, levellers, scrapers, mechanical shovels, excavators, shovel loaders, tamping machines and roadrollers

8434 - Milking machines and dairy machinery

8435 - Presses, crushers and similar machinery used in the manufacture of wine, cider, fruit juices or similar beverages

8436 - Other agricultural, horticultural, forestry, poultry-keeping or bee-keeping machinery, including germination plant fitted with mechanical or thermal equipment; poultry incubators and brooders

8437 - Machines for cleaning, sorting or grading seed, grain or dried leguminous vegetables; machinery used in the milling industry or for the working of cereals or dried leguminous vegetables, other than farm-type machinery

8454 - Converters, ladles, ingot moulds and casting machines, of a kind used in metallurgy or in metal foundries

8455 - Metal-rolling mills and rolls therefor

8456 - Machine tools for working any material by removal of material, by laser or other light or photon beam, ultrasonic, electrodischarge, electrochemical, electron beam, ionic-beam or plasma arc processes; water-jet cutting machines

8457 - Machining centres, unit construction machines (single station) and multi-station transfer machines, for working metal

8458 - Lathes (including turning centres) for removing metal

8459 - Machine tools (including way-type unit head machines) for drilling, boring, milling, threading or tapping by removing metal, other than lathes (including turning centres) of heading 8458

8460 - Machine tools for deburring, sharpening, grinding, honing, lapping, polishing or otherwise finishing metal or cermets by means of grinding stones, abrasives or polishing products, other than gear cutting, gear grinding or gear finishing machines of heading 8461

8461 - Machine tools for planing, shaping, slotting, broaching, gear cutting, gear grinding or gear finishing, sawing, cutting-off and other machine tools working by removing metal or cermets, not elsewhere specified or included

8462 - Machine tools (including presses) for working metal by forging, hammering or die forging (excluding rolling mills); machine tools (including presses, slitting lines and cut-to-length lines) for working metal by bending, folding, straightening, flattening, shearing, punching, notching or nibbling (excluding draw-benches); presses for working metal or metal carbides, not specified above

8463 - Other machine tools for working metal or cermets, without removing material

8464 - Machine tools for working stone, ceramics, concrete, asbestos-cement or like mineral materials or for cold working glass

8465 - Machine tools (including machines for nailing, stapling, glueing or otherwise assembling) for working wood, cork, bone, hard rubber, hard plastics or similar hard materials

8519 - Sound recording or sound reproducing apparatus

8521 - Video recording or reproducing apparatus, whether or not incorporating a video tuner
